**Exhibits and displays must be securely arranged.** Any food items must be wrapped; and, if sold by the piece, must be individually sealed. **No raffles or solicitations are allowed.**

### **2020 Participants Time-Line and Wait List for New 2021 Applicants:**

**APPLICATION:** Signed and completed applications must be returned along with a check for the booth fee; (no money-orders). 2020 vendors have until March 31, 2021 to secure their booth space(s) by sending in their application and fees. If you are new to the show, you will be placed on a 'wait list' based on the date the application is received. Unclaimed spaces of 2020 artisans will be made available to new applicants after March 31, 2021 on a first come, first served basis, so the earlier your application and fees are received, the better chance that you will get a booth space. Spaces may not be transferred to other artisans. All artisans who have been accepted will be notified of their acceptance via e-mail.

**FAIR WILL GO ON DESPITE SNOW,ICE,RAIN OR BAD ROAD CONDITIONS.** **No refunds for weather-related issues.**

**SELLER'S PERMIT AND SECURITY:** Each vendor must have a **CA Seller's** permit valid for the temporary location of the 'Towers'(California BOE rule). The permit number must be listed on the application. Forms for this temporary location are available at no cost. Contact the California Tax Service Center: <https://www.cdtfa.ca.gov> or call (800)400-7115. Failure to comply may result in a \$1000.00 fine. We cannot allow vendors to sell their creations without the seller's permit as the Marble Rim Gallery could be liable.

**SET UP AND CLEAN UP:** **Set-up time is daylight til 9:30.** After unloading, vendors must move their vehicles out of the parking lot and park behind the site to ensure adequate parking for customers. Take-down at 4 pm. Please remove all items and trash.
